## FUND OBJECTIVES

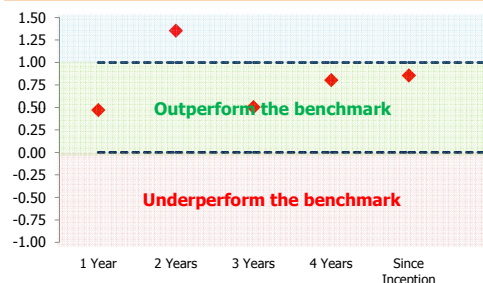

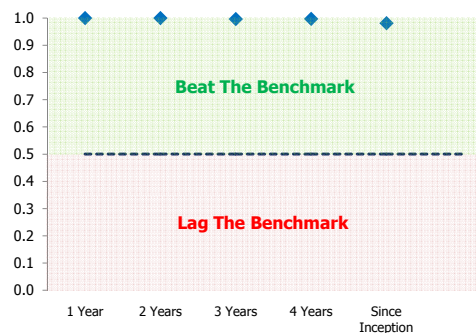
## MANAGER PERFORMANCE

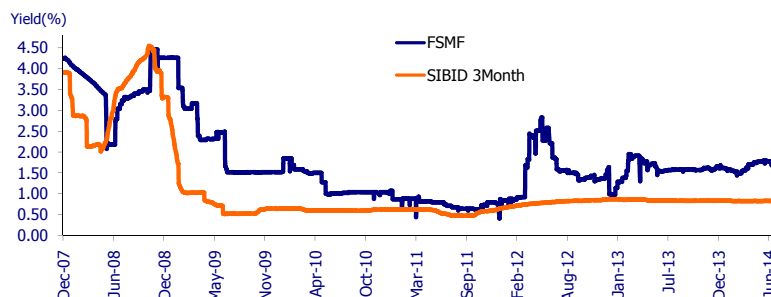

## PERFORMANCE FUND YIELD VS BENCHMARK

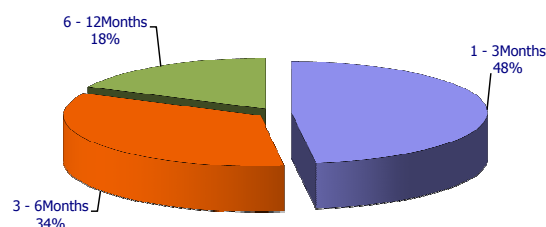
