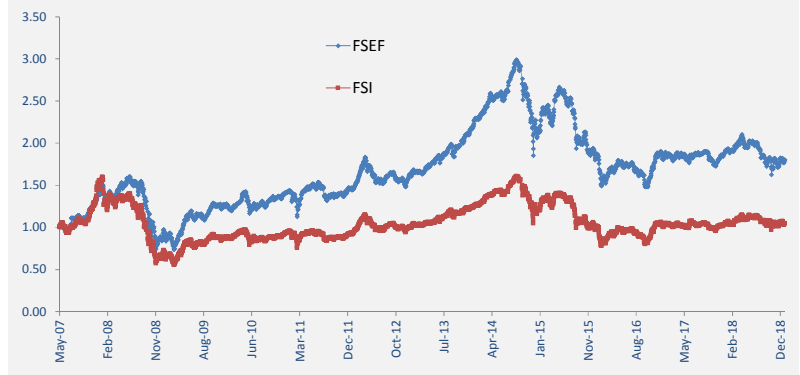

## Performance Fund vs Benchmark

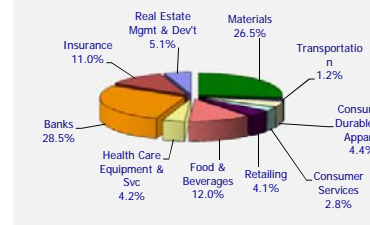
